Nomination Criteria

Nominees should exemplify excellence in one or more of the following areas:

1. Innovation & Process Improvement

The nominee has demonstrated a commitment to advancing manufacturing processes, introducing innovative solutions, or championing the adoption of new technologies that have resulted in significant improvements in efficiency, productivity, or sustainability.

2. Industry Leadership & Vision

The nominee has shown exceptional leadership in guiding their organisation or the broader industry through challenges, inspiring positive change, and driving the vision for the future of manufacturing in New Zealand.

3. Impact on Workforce Development

The nominee has contributed to the growth and development of the workforce by fostering skills training, upskilling initiatives, and employee engagement programs that help develop the next generation of manufacturing leaders.

4. Sustainability & Environmental Stewardship

The nominee has made substantial contributions to promoting sustainability within the manufacturing sector, such as implementing environmentally responsible practices, improving resource efficiency, or developing solutions that reduce environmental impact.

5. Advancing Competitiveness & Global Reach

The nominee has played a key role in enhancing the competitiveness of New Zealand's manufacturing sector on a global scale, through strategic initiatives that increase market share, expand export opportunities, or improve operational performance.

6. Community Impact

The nominee has demonstrated a commitment to community engagement, either through supporting regional communities or being a positive advocate for New Zealand's manufacturing sector.



Nomination Process

Submission Requirements:

- o Nominations must be submitted via the official entry form.
- Nominations must be submitted by 5pm, Friday 7th March 2025.

Evaluation and Selection:

All nominations will be assessed by an independent judging panel.
