New Zealand manufacturing businesses are invited to nominate one apprentice per business unit or manufacturing facility.

Definitions

What is an apprentice?

For the purposes of this award, an apprentice is defined as:

- 1. A person undertaking paid work leading to a trade or related occupation.
- A person undertaking structured training with a registered training organisation, resulting in a nationally recognised qualification under the New Zealand Qualifications Framework.
- 3. A person receiving on-the-job training with a workplace supervisor.



Nomination Criteria

1. Nominator Requirements:

- Nominations must be submitted by a New Zealand-based manufacturing business.
 (Businesses with international ownership but operating in New Zealand are eligible.)
- A senior representative (e.g., manager or supervisor) must act as the official nominator. Recruitment agencies, labour hire companies, and registered training organisations may not nominate.

2. Nominee Requirements:

- The nominee must be an apprentice as defined in the "Definitions" section.
- The nominee must be a New Zealand citizen, resident, or hold a visa entitling them to work and undertake training in New Zealand during the event period.

3. Entry Limitations:

Only one nomination may be submitted per business unit or manufacturing facility.

Nomination Process

4. Submission Requirements:

- Nominations must be submitted via the official entry form.

- A valid entry includes:
 - Nominator and nominee names and contact details.
 - Nominee's employer name, address, and NZBN.
 - Details of the apprenticeship type and the year currently being completed.
 - Responses to all criteria in the nomination form.
- Nominations must be submitted by 10am Monday 7th April 2025.

5. Evaluation and Selection:

o All nominations will be assessed by an independent judging panel.

6. Judging Criteria:

Nominations must highlight how the nominee:

- Demonstrates leadership and initiative in their work environment.
- Supports team members and contributes to an inclusive culture.
- Communicates effectively and maintains a positive attitude.



Privacy and Publicity

7. Use of Information:

- By entering, nominators and nominees grant permission for AMA to use the following non-confidential information for purposes directly related to the Minister for Manufacturing Awards publicity:
 - Nominee names and likenesses (e.g. photographs, video and/or sound recordings and written materials).
 - Nominating company name
 - General nomination details (e.g. apprenticeship type, achievements outlined in the nomination form)
- The information will be used solely for:
 - Promoting the Minister for Manufacturing Awards.
 - Recognising the achievements of nominees and winners.

Additional Terms

8. Decisions Are Final:

 Judging panel decisions are final, and no correspondence regarding these decisions will be entered into.
